
# 2 Map visualisation (i)

This section contains visualisations of the EMDB entry EMD-11787. These allow visual inspection of the internal detail of the map and identification of artifacts.






The images above show the map projected in three orthogonal directions.











The images above show central slices of the map in three orthogonal directions.








The images above show the largest variance slices of the map in three orthogonal directions.




### 2.4 Orthogonal surface views (i)

#### 2.4.1 Primary map



The images above show the 3D surface view of the map at the recommended contour level 0.0082. These images, in conjunction with the slice images, may facilitate assessment of whether an appropriate contour level has been provided.

#### 2.4.2 Raw map



These images show the 3D surface of the raw map. The raw map's contour level was selected so that its surface encloses the same volume as the primary map does at its recommended contour level.




# 2.5 Mask visualisation (i)

This section shows the 3D surface view of the primary map at 50% transparency overlaid with the specified mask at 0% transparency

A mask typically either:

- Encompasses the whole structure
- Separates out a domain, a functional unit, a monomer or an area of interest from a larger structure






# 3 Map analysis (i)

This section contains the results of statistical analysis of the map.


# 3.1 Map-value distribution (i)



The map-value distribution is plotted in 128 intervals along the x-axis. The y-axis is logarithmic. A spike in this graph at zero usually indicates that the volume has been masked.



# 3.2 Volume estimate (i)




The volume at the recommended contour level is 158  $\text{nm}^3$ ; this corresponds to an approximate mass of 142 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.



# 4 Fourier-Shell correlation (i)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. The shape of the curve depends on the imposed symmetry, mask and whether or not the two 3D reconstructions used were processed from a common reference. The reported resolution is shown as a black line. A curve is displayed for the half-bit criterion in addition to lines showing the 0.143 gold standard cut-off and 0.5 cut-off.

\*Resolution estimate based on FSC curve calculated by comparison of deposited half-maps. The value from deposited half-maps intersecting FSC 0.143 CUT-OFF 3.28 differs from the reported value 2.9 by more than 10 %
