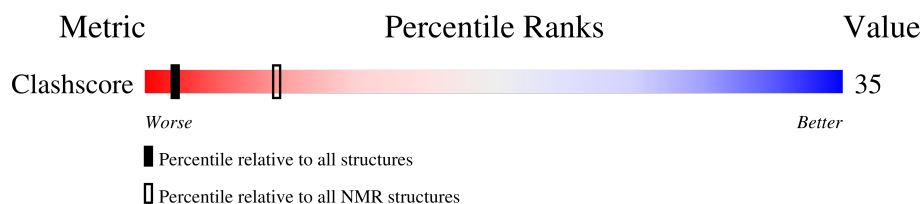
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 100%.

2 Ensemble composition and analysis

This entry contains 20 models. This entry does not contain polypeptide chains, therefore identification of well-defined residues and clustering analysis are not possible. All residues are included in the validation scores.

3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 142 atoms, of which 80 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein (with D amino acids) called Cyclic peptide D8.21 DVA-MLE-DPR-LEU-DVA-MLE-DPR-LEU.

4 Residue-property plots

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

4.2 Residue scores for the representative (author defined) model from the NMR ensemble

The representative model is number 1. Colouring as in section [4.1](#) above.

In the following table, the Counts columns list the number of angles for which Mogul statistics could be retrieved, the number of angles that are observed in the model and the number of angles that are defined in the chemical component dictionary. The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond angle is the number of standard deviations the observed value is removed from the expected value. A bond angle with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond angles.

7.1.3 Completeness of resonance assignments [i](#)

The overall completeness is 100%, i.e. 28 atoms were assigned a chemical shift out of a possible 28. 0 out of 2 assigned methyl groups (LEU and VAL) were assigned stereospecifically.
