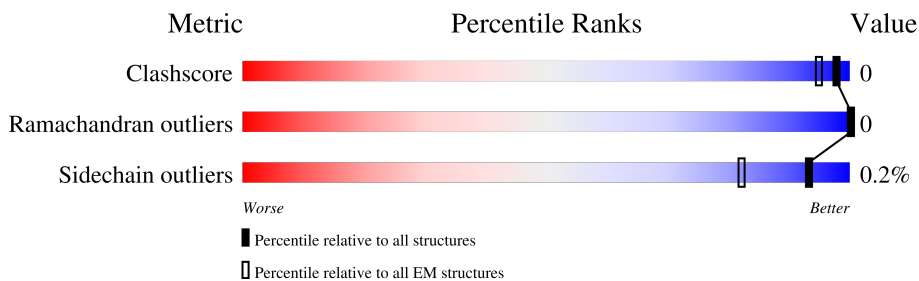
1 Overall quality at a glance i

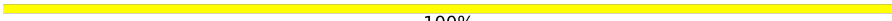

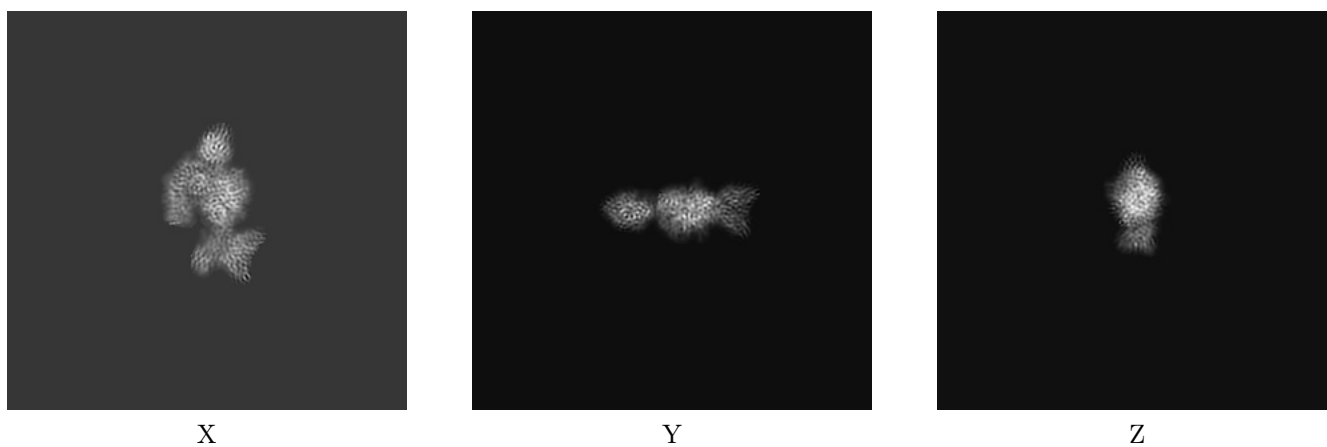

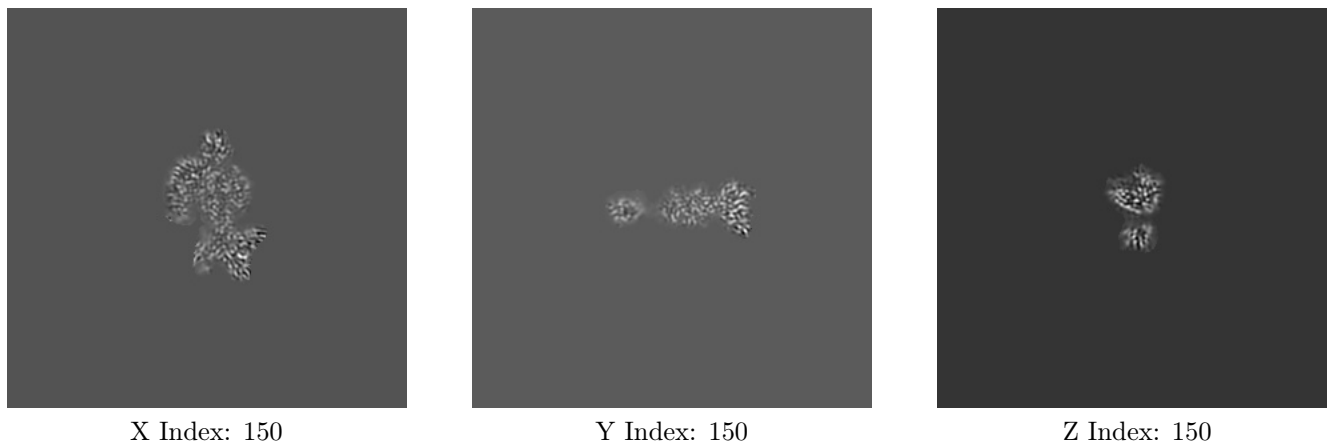

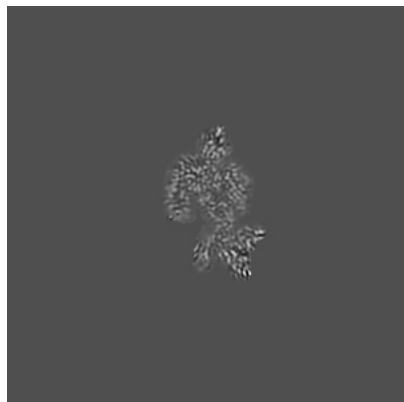

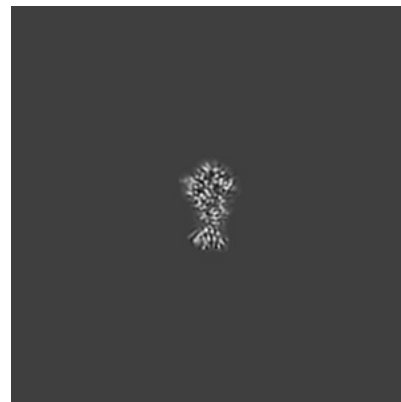

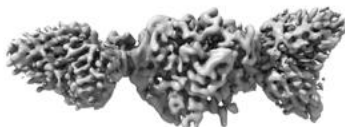

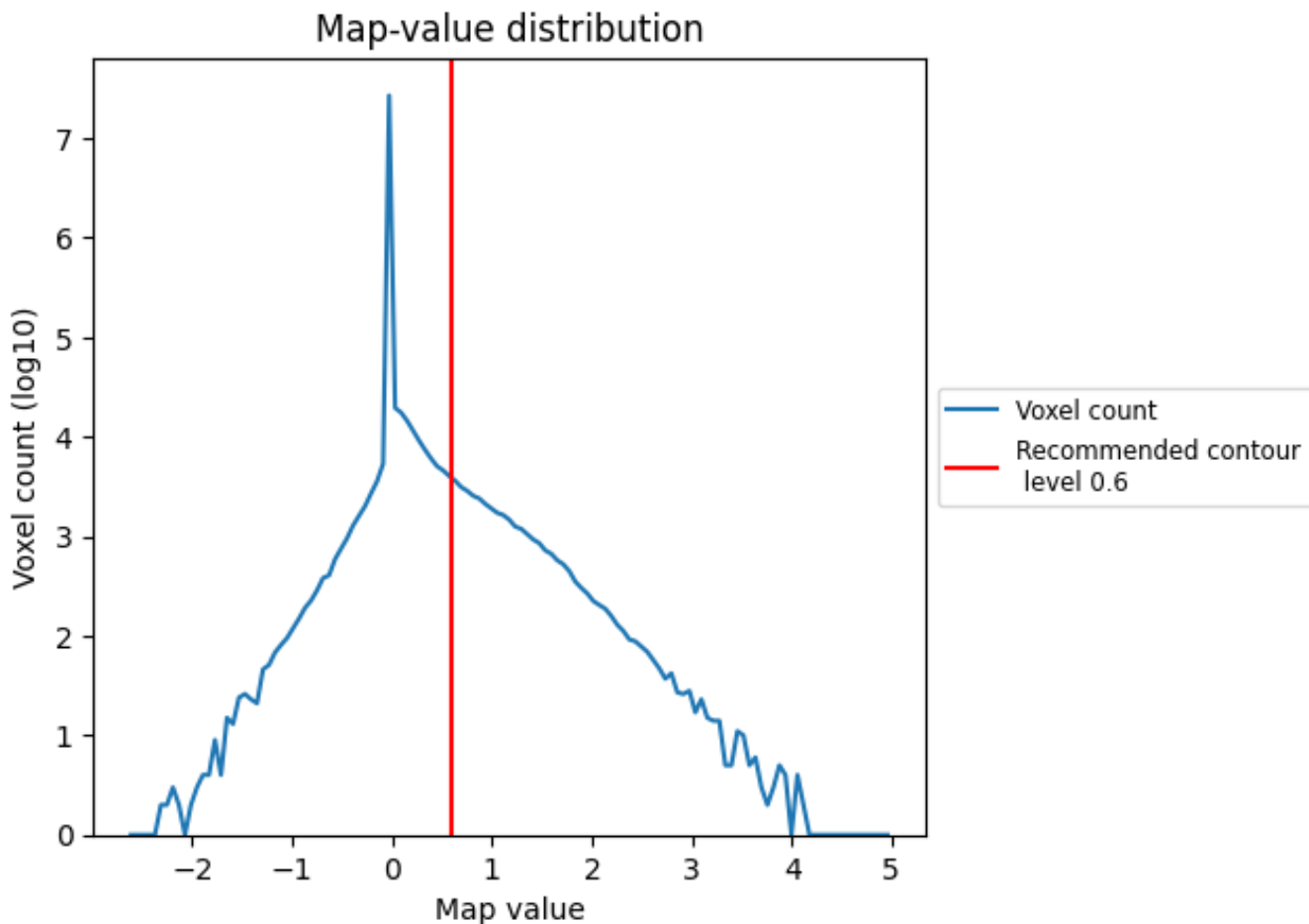

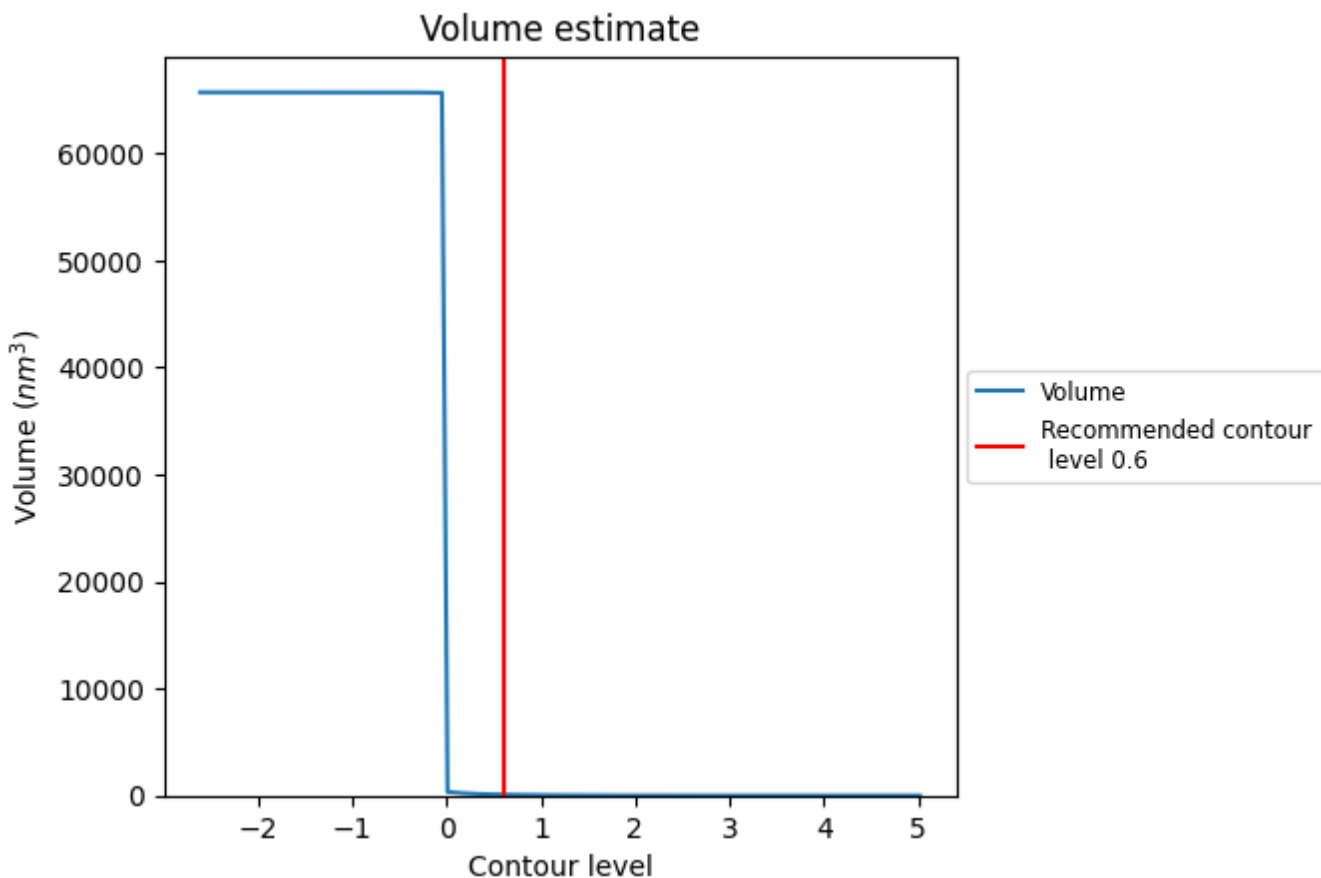

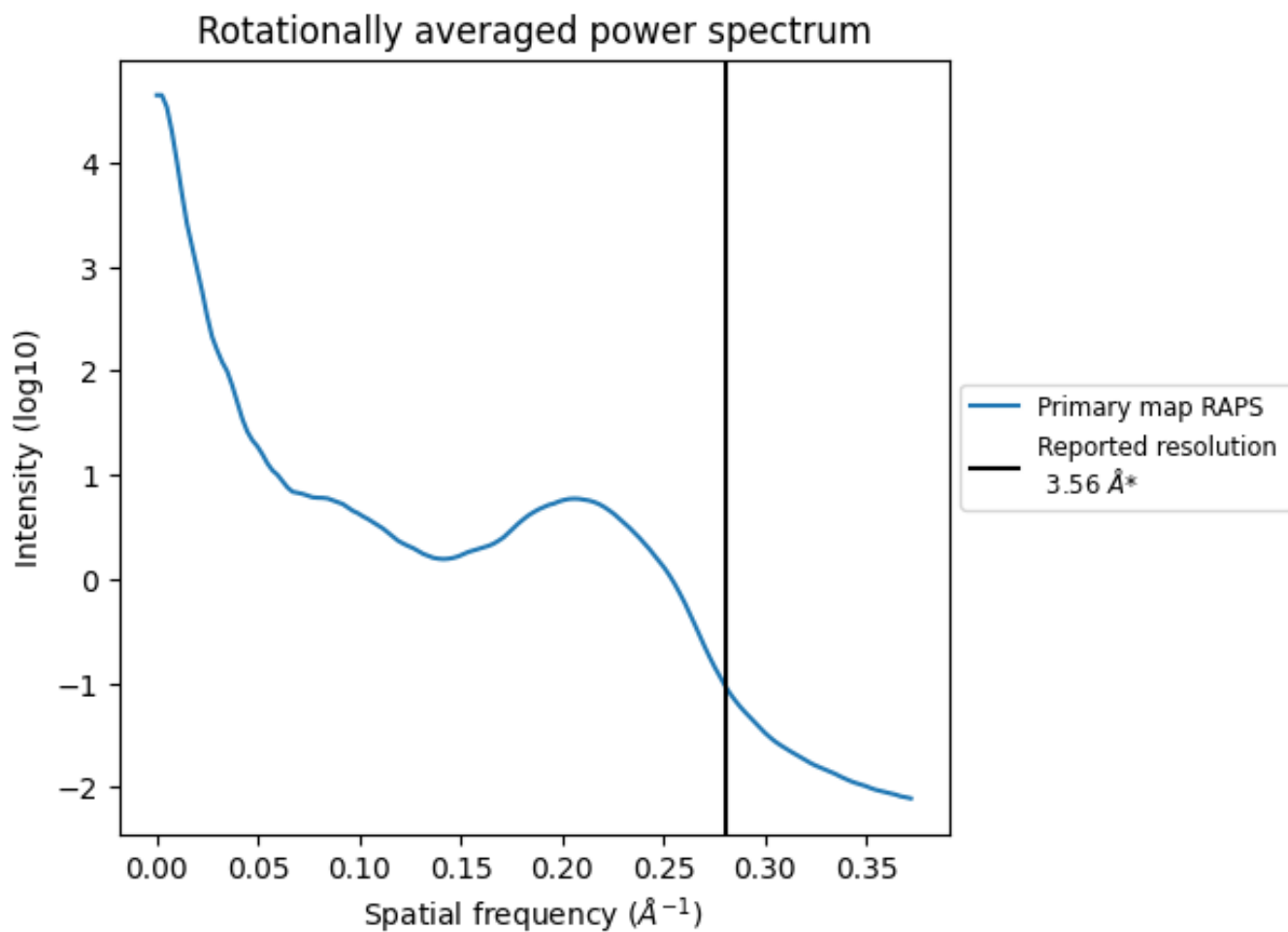
7.2 Volume estimate [i](#)



The volume at the recommended contour level is 89 nm³; this corresponds to an approximate mass of 80 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.

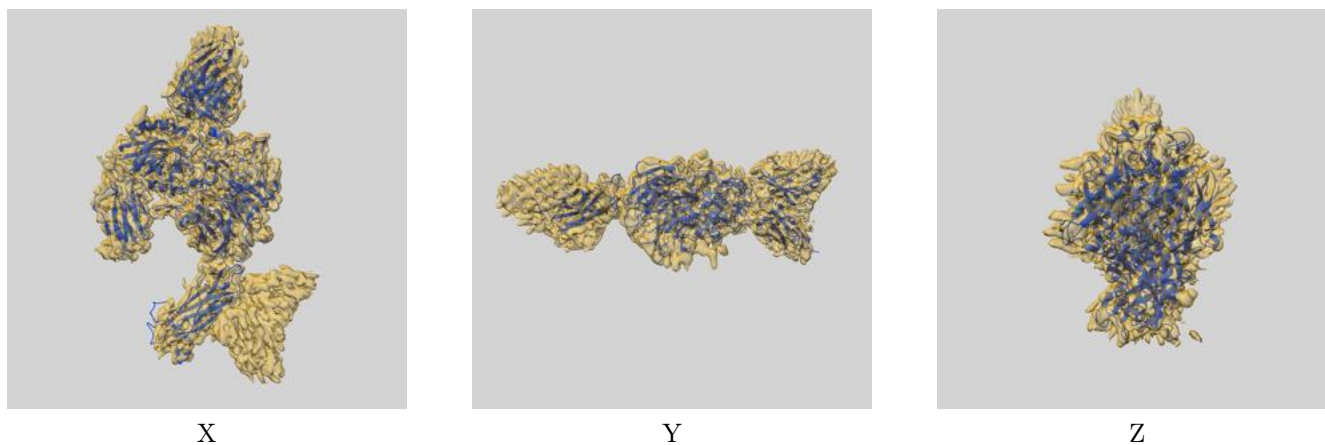

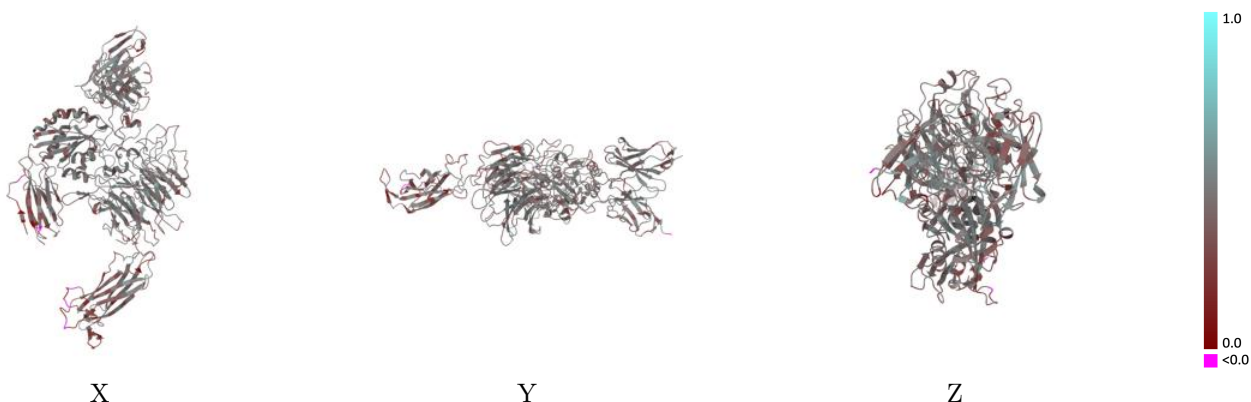

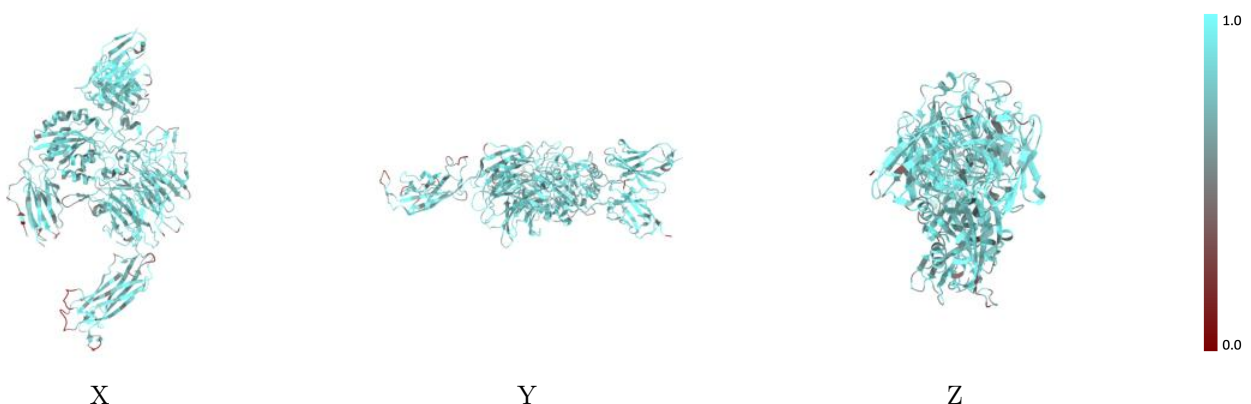

9.2 Q-score mapped to coordinate model [\(i\)](#)



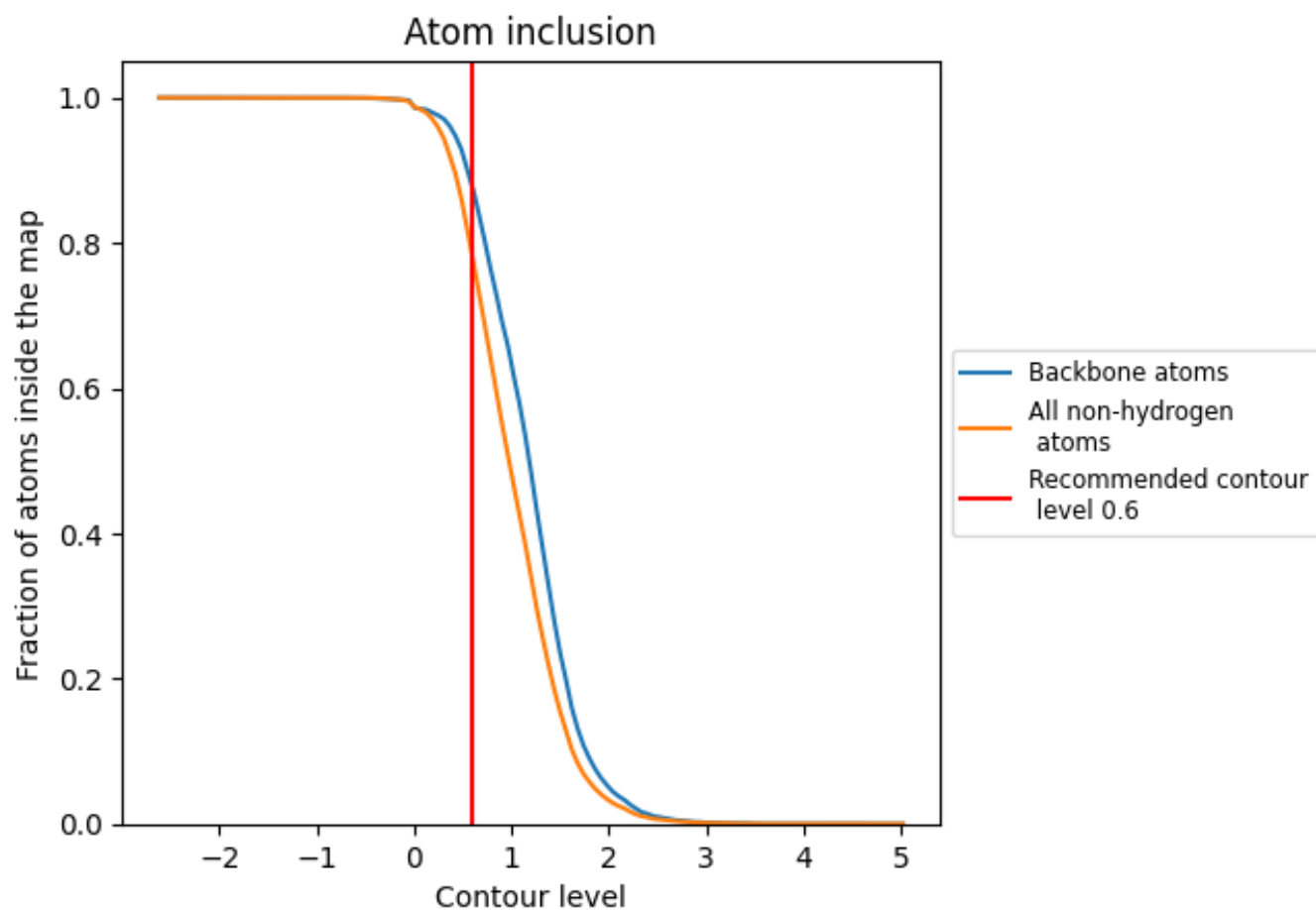
The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability. Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.

At the recommended contour level, 88% of all backbone atoms, 78% of all non-hydrogen atoms, are inside the map.
