

1 Overall quality at a glance (i)

A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5% The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion <40%). The numeric value is given above the bar.




3 Residue-property plots (i)

These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry and atom inclusion in map density. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. A red diamond above a residue indicates a poor fit to the EM map for this residue (all-atom inclusion < 40%). Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.


• Molecule 1: NADH dehydrogenase [ubiquinone] flavoprotein 1, mitochondrial







• Molecule 9: NADH dehydrogenase ubiquinone 1 alpha subcomplex subunit 9, mitochondrial













 \bullet Molecule 14: NADH dehydrogenase [ubiquinone] flavoprotein 2, mitochondrial




• Molecule 15: NADH dehydrogenase [ubiquinone] iron-sulfur protein 3, mitochondrial





5.1 Standard geometry (i)

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with |Z| > 5 is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

The all-atom clashscore is defined as the number of clashes found per 1000 atoms (including hydrogen atoms). The all-atom clashscore for this structure is 8.

The worst 5 of 451 close contacts within the same asymmetric unit are listed below, sorted by their clash magnitude.






The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. 






The images above show central slices of the map in three orthogonal directions.








7.1 Map-value distribution (i)






9.1 Map-model overlay (i)




9.2 Q-score mapped to coordinate model (i)


