## 1 Overall quality at a glance (i)

The following experimental techniques were used to determine the structure: SOLID-STATE NMR

The overall completeness of chemical shifts assignment is $4 \%$.

## 4 Residue-property plots (i)

### 4.1 Average score per residue in the NMR ensemble

The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green $=0$, yellow $=1$, orange $=2$ and red $=$ 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

### 7.1.3 Completeness of resonance assignments (i)

### 7.1.5 Random Coil Index (RCI) plots (i)

The image below reports random coil index values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the welldefined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
