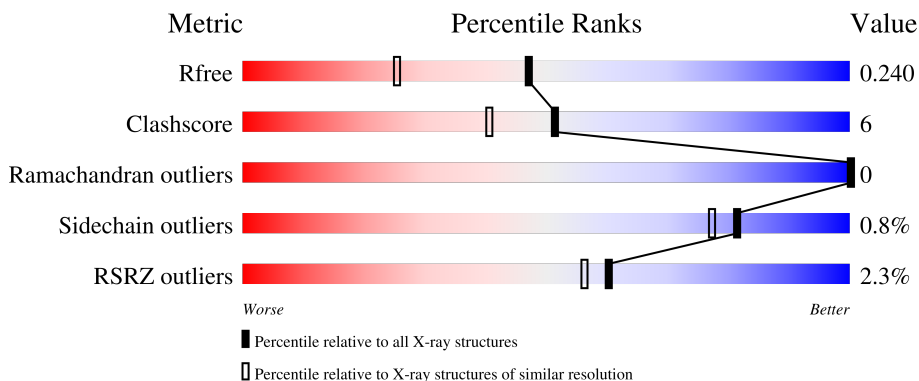
# 1 Overall quality at a glance

*X-RAY DIFFRACTION*


The reported resolution of this entry is 1.82 Å.

The red, orange, yellow and green segments of the lower bar indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.

## 2 Entry composition [i](#)

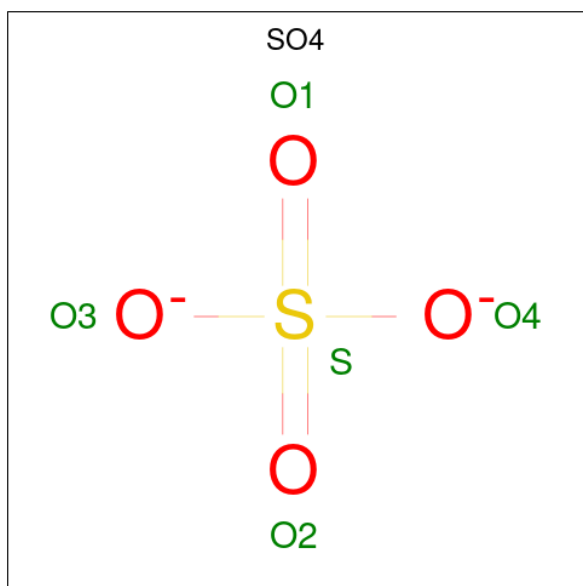

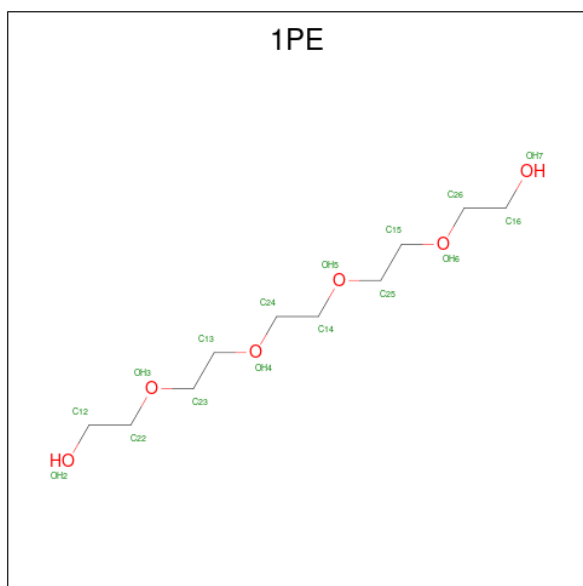

Xtrriage's analysis on translational NCS is as follows: *The largest off-origin peak in the Patterson function is 5.64% of the height of the origin peak. No significant pseudotranslation is detected.*

## 5 Model quality

### 5.1 Standard geometry

Bond lengths and bond angles in the following residue types are not validated in this section: SO4, GOL, 1PE

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).
