1 Overall quality at a glance (i)

The overall completeness of chemical shifts assignment was not calculated.

There are no overall percentile quality scores available for this entry.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

4 Residue-property plots (i)

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

5 Refinement protocol and experimental data overview (i)

The models were refined using the following method: *matrix relaxation, simulated annealing, distance restraints, dihedral angle restraints.*

Of the 20 calculated structures, 1 were deposited, based on the following criterion: the submitted structure is an average of 10 different structures that were back calculated and the data agreed with experimental NOESY spectrum.
