

1 Overall quality at a glance (i)

The following experimental techniques were used to determine the structure: $SOLID\text{-}STATE \ NMR$

The overall completeness of chemical shifts assignment is 7%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

2 Ensemble composition and analysis (i)

This entry contains 10 models. Model 2 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *lowest energy*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 2 clusters and 2 single-model clusters were found.

3 Entry composition (i)

There is only 1 type of molecule in this entry. The entry contains 362 atoms, of which 184 are hydrogens and 0 are deuteriums.

• Molecule 1 is a protein called Piscidin-3.




4 Residue-property plots (i)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.





5 Refinement protocol and experimental data overview (i)

The models were refined using the following method: *simulated annealing*.

Of the 100 calculated structures, 10 were deposited, based on the following criterion: *structures* with the lowest energy.

7.1.2 Chemical shift referencing (i)

No chemical shift referencing corrections were calculated (not enough data).

7.1.3 Completeness of resonance assignments (i)

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 7%, i.e. 17 atoms were assigned a chemical shift out of a possible 245. 0 out of 1 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

The overall completeness is 7%, i.e. 21 atoms were assigned a chemical shift out of a possible 290. 0 out of 2 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

Note: This is a solid-state NMR structure, where hydrogen atoms are typically not assigned a chemical shift value, which may lead to lower completeness of assignment measure.

7.1.4 Statistically unusual chemical shifts (i)

The following table lists the statistically unusual chemical shifts. These are statistical measures, and large deviations from the mean do not necessarily imply incorrect assignments. Molecules containing paramagnetic centres or hemes are expected to give rise to anomalous chemical shifts.

7.1.5 Random Coil Index (RCI) plots (i)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
