

## 2 Entry composition (i)


There are 6 unique types of molecules in this entry. The entry contains 2145 atoms, of which 0 are hydrogens and 0 are deuteriums.

Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 6.70% of the height of the origin peak. No significant pseudotranslation is detected.





The following is a graphical depiction of the model fit to experimental electron density for oligosaccharide. Each fit is shown from different orientation to approximate a three-dimensional view.







The following is a graphical depiction of the model fit to experimental electron density of all instances of the Ligand of Interest.
