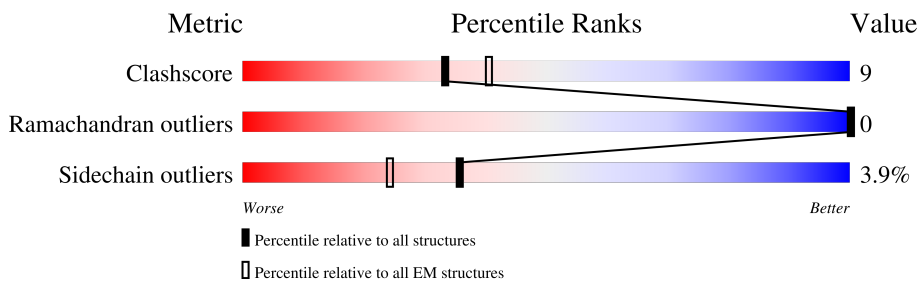
# 1 Overall quality at a glance i

The following experimental techniques were used to determine the structure:

*ELECTRON MICROSCOPY*

The reported resolution of this entry is 2.61 Å.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the map. The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion  $< 40\%$ ). The numeric value is given above the bar.

## 2 Entry composition [i](#)

There are 4 unique types of molecules in this entry. The entry contains 49868 atoms, of which 140 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

- Molecule 1 is a protein called Glutamine synthetase.

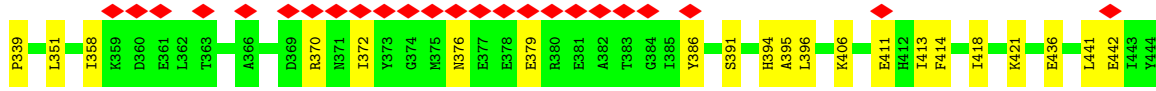

Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

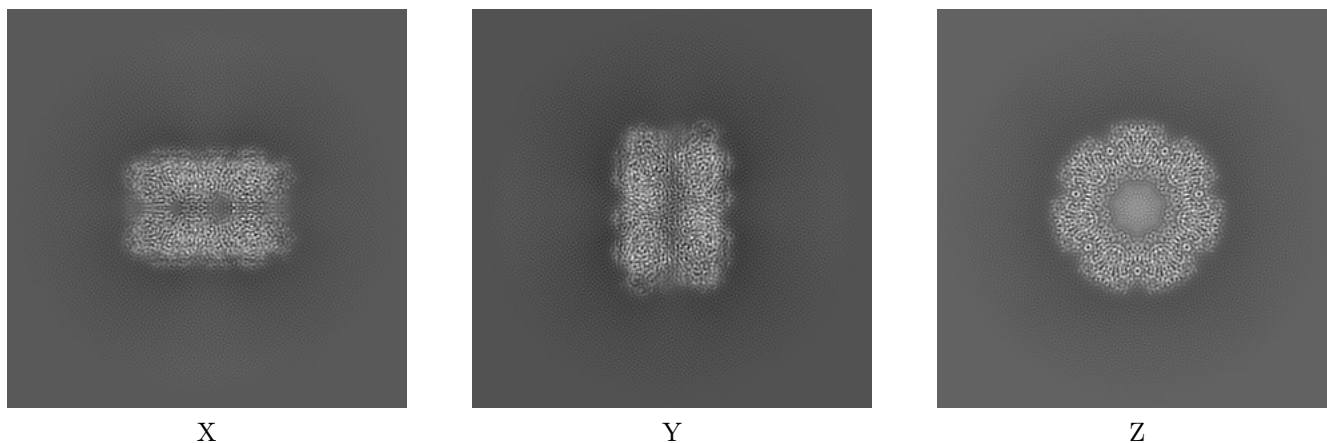

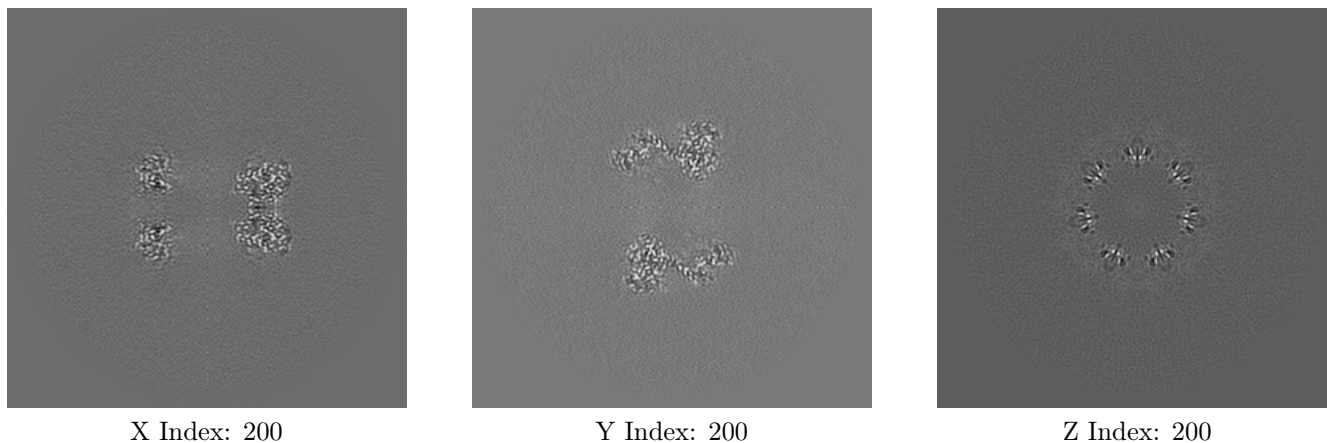

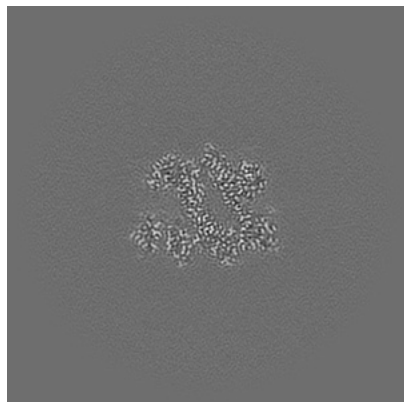

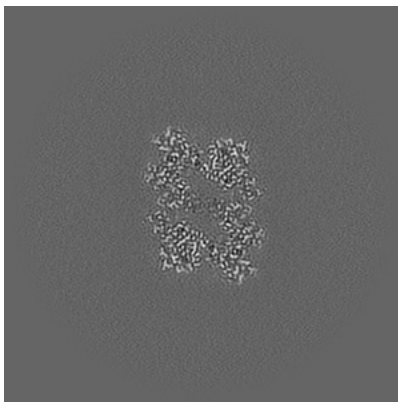

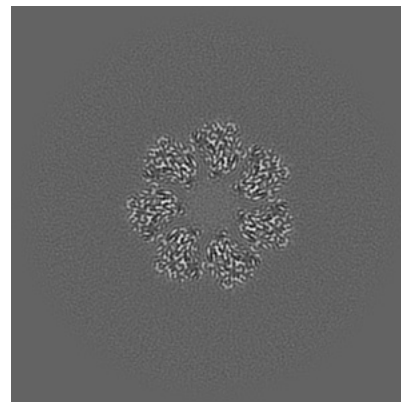

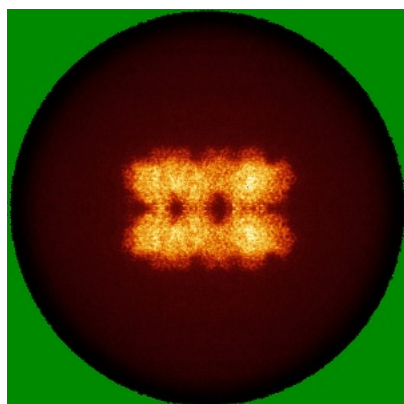

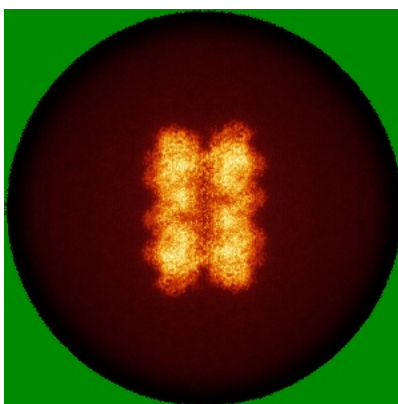

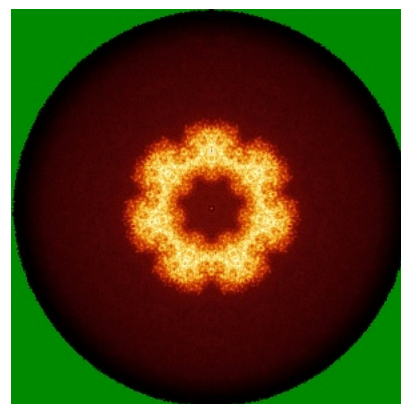

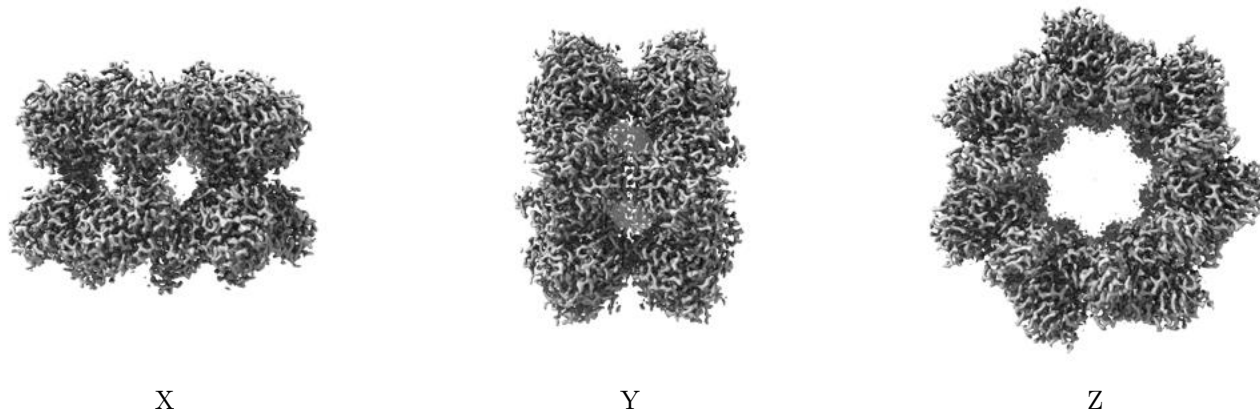

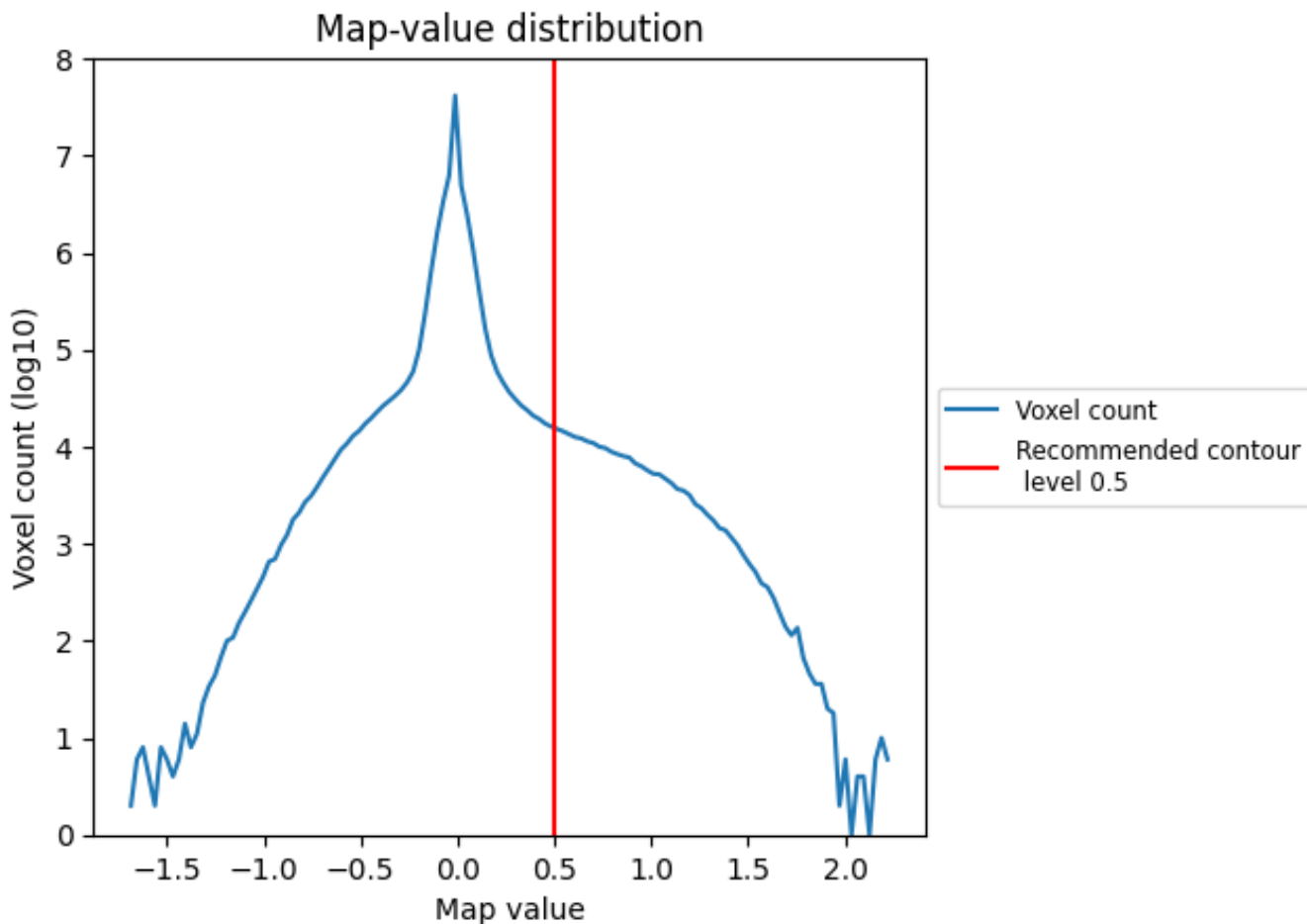

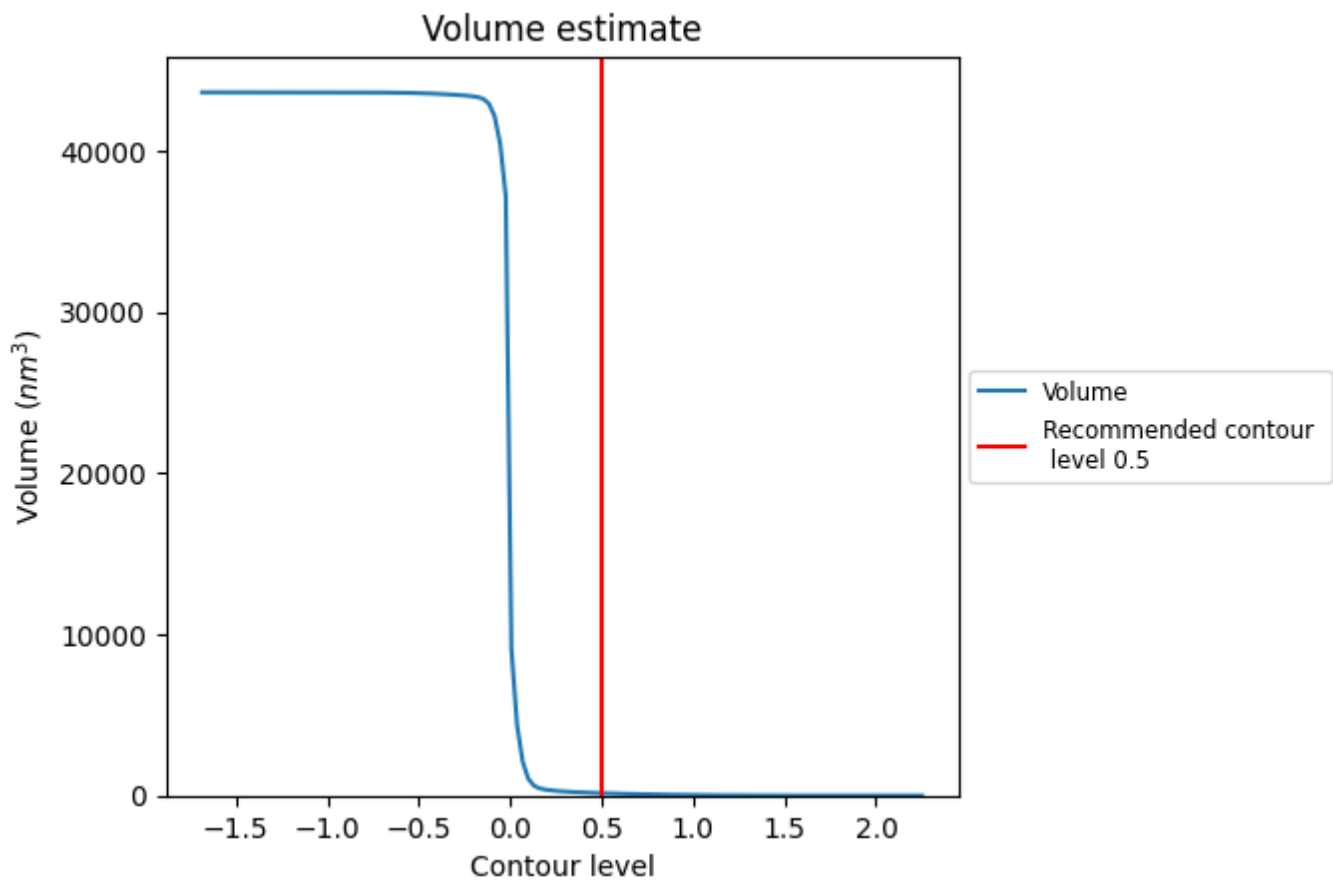
### 7.1 Map-value distribution [i](#)

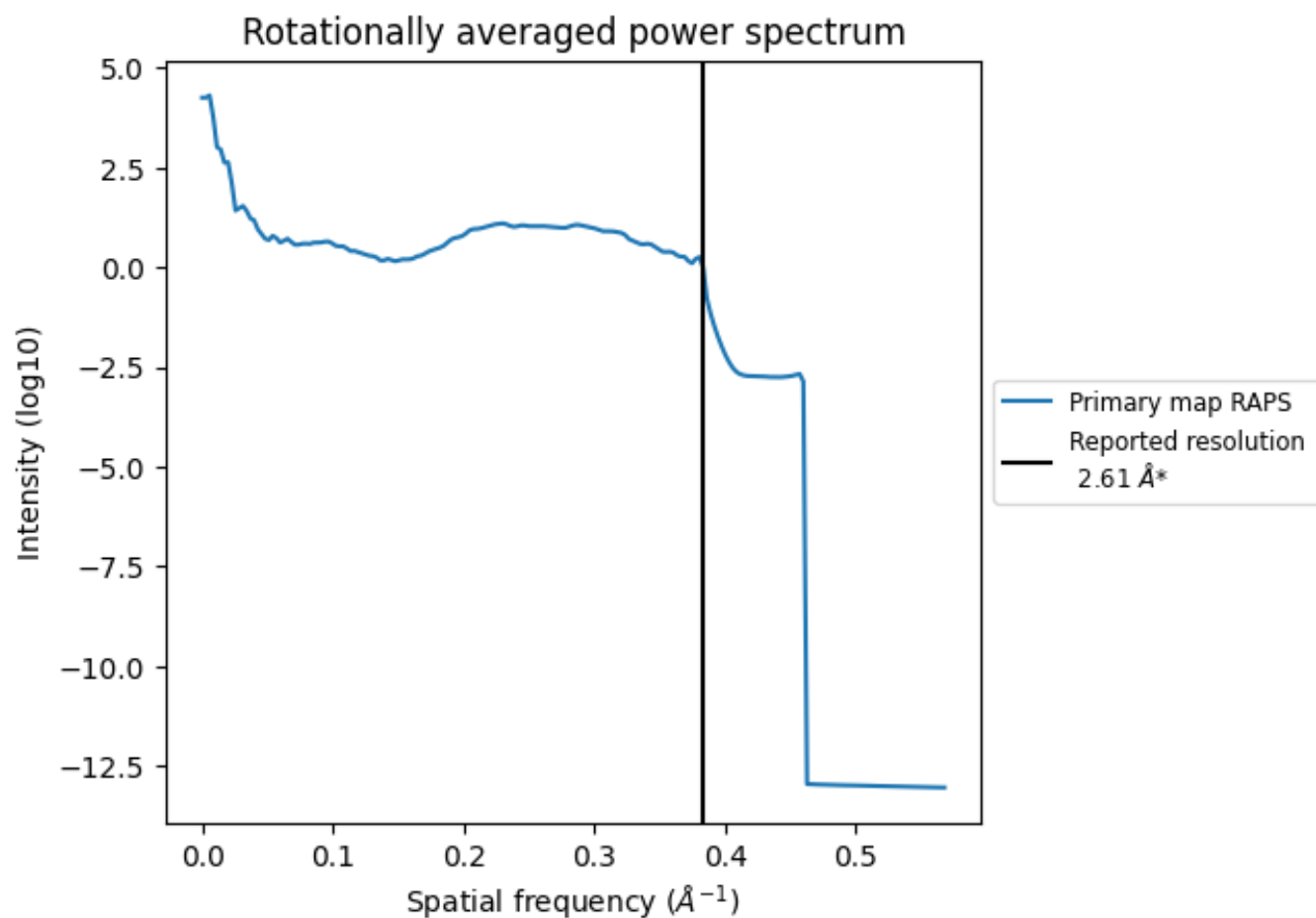
## 7.2 Volume estimate [i](#)

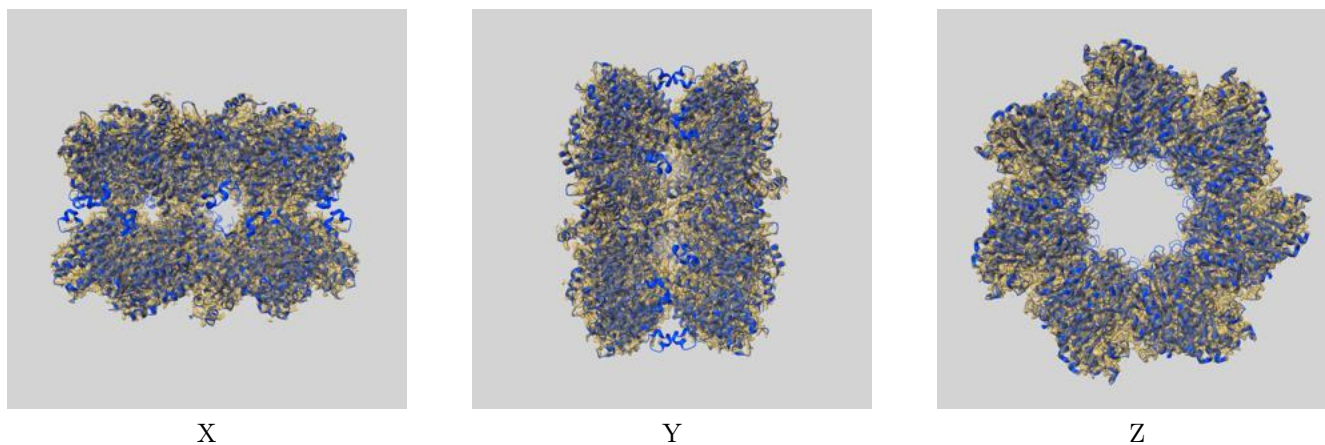

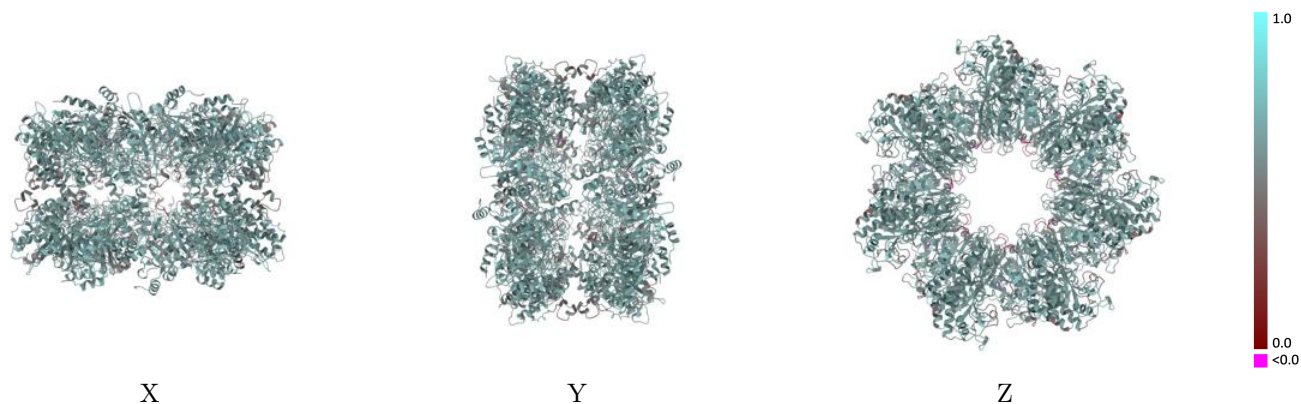

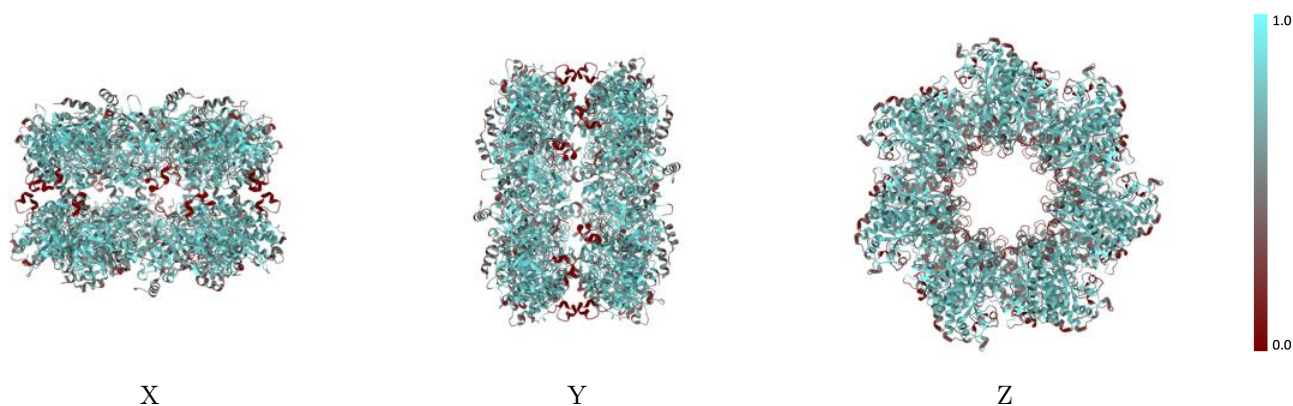

## 9.2 Q-score mapped to coordinate model [\(i\)](#)



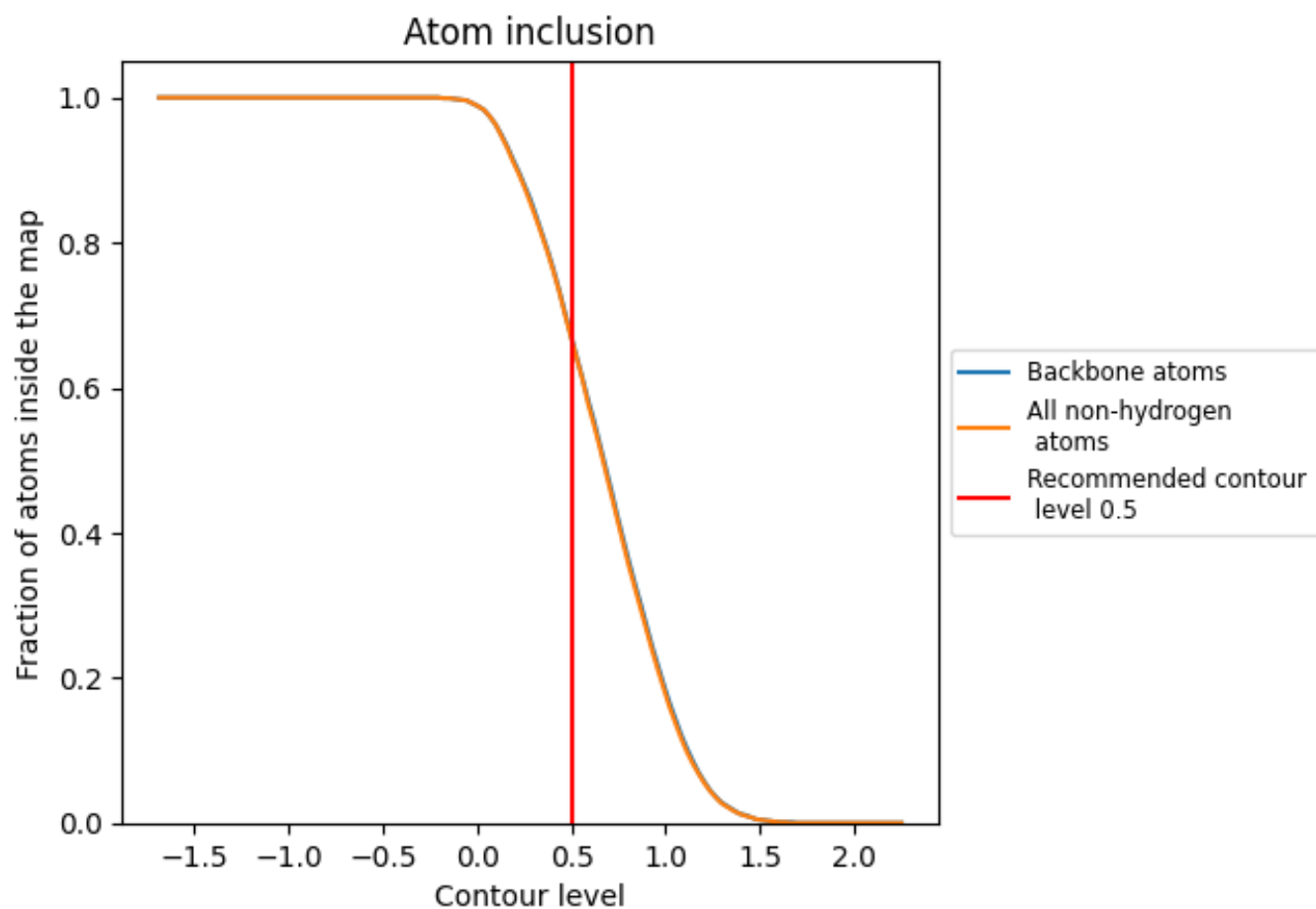
