## 1 Overall quality at a glance (i)

## X-RAY DIFFRACTION

The reported resolution of this entry is $2.50 \AA$.

## 2 Entry composition (i)

There are 4 unique types of molecules in this entry. The entry contains 3348 atoms, of which 0 are hydrogens and 0 are deuteriums.

## 3 Residue-property plots (i)

These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green $=0$, yellow $=1$, orange $=2$ and red $=3$ or more. Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is $4.67 \%$ of the height of the origin peak. No significant pseudotranslation is detected.

## 5 Model quality (i)

### 5.1 Standard geometry (i)

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand.A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.
